The lot of land now my residence to my Nephew Kerney Young now with me my land in the State of Alabama to be sold and the proceeds to the children of Augustin and Wilson Youngs to Redman B. Young and Asberry Young three cows and calves each my household and kitchen furniture to sold and the proceeds to said Augustin and Wilsons children Lot of land one hundred and fifty three in this district to Kerney Young my nephew and levi my negro boy the ballance of my negroes sold and the money Equally divided between the children of Augustin Wilson and Bennetts children. 25th April 1841. CARROLL COUNTY METHODISM FROM 1828 TO 1927

By Rev. Irby Henderson, Pastor First Methodist Church, Carrollton, GA.

The scope of our research for data around which to organize this historical sketch has been limited to the territory embraced in Carroll County at this time, 1927. In communities that were formerly in Carroll County but are now in other counties there are probably Methodist churches quite as ancient as any within the present bounds of the county.

According to the recorded and traditional facts that we have been able to collect the distinction of being the "Mother Church" of Carroll County Methodism belongs to Concord Methodist Episcopal Church, South, by a very lengthy margin. This church was organized with thirteen members in the year 1828, the first year that an appointment is made by the Georgia Conference to Coweta and Carroll Mission. We have not been able to ascertain who the pastor was for that year, the appointment reading, "To be supplied." The following year the appointment reads, "Coweta and Carroll Mission -- Simeon L. Stephens." In 1830 the name is "Carroll Mission," and the preacher is George W. Pournell. It is commonly believed that the prime mover, humanly speaking, in the organization of Concord Church was James Baskin, who was born in South Carolina in 1800, reared in Jackson County, Ga., and moved to Hickory Level, Carroll County, in 1828. He had exercised as a class leader prior to coming to this county and continued in this official position until 1835, when he was licensed an exhorter. In 1837, he was licensed to preach. In 1846, he was ordained deacon, and in 1857, he was ordained as elder. This relation he sustained to the church until his death in 1888. Like David of old, "he served his generation by the will of God" and is yet living and serving in the lives of a multitude of descendants who "walk by the same rule and mind the same things." Other local preachers who belonged to this historic old church have wrought well and done much for the furtherance of the gospel, several of them serving as "Supplies" at different times and in different places, are: Revs. James Bryce, James Stripling, David Stripling, William Brooks, Frank Powell, Thos. Powell, J. F. Bryce, C. W. Baskin, Bird Kelley, Jesse Garrison, and Sam Baskin. Rev. William Baxter, Rev. J. Y. Bryce, and Rev. G. R. Bryce went from Concord into the Conference as itinerant preachers.

As late as 1869, there were sixteen colored members of Concord Church, one of them, Rev. Larkin Walker, being a local preacher. Prior to the War Between the States it was the common practice for colored people to belong to the same churches as the white people, there being especial sections of the meeting-houses set apart for their accommodation.

The Concord congregation are now using the fifth church edifice to be constructed upon the original spot of ground whereon stood the log meeting-house, 18 feet square, erected in 1828.

The present building is a commodious and beautiful brick structure finished in the year 1906, during the pastorate of Rev. J. W. Gober.

The membership of Concord is now around three hundred, and there is preaching two Sundays in each month, this church and Temple constituting a pastoral charge. Rev. W. E. Brown is now closing out his second year as pastor on the charge. 10 ... 11 26-02 -88-

CARROLLTON

We have not been able to find a record of the organization of the Methodist Church in Carrollton, but from the records in the Clerk's office we find that they acquired property in 1850. Tradition has it that the church had been organized several years before that date, and that they had used a community chapel or school house for their services. The first church building was erected on the parcel of ground north of Alabama street that is now used for a cemetery. In 1880, the lot on Newnan street was acquired and a timber-building erected thereupon. This building was used until 1904, when it was dismantled and moved to Hulett, and re-assembled, it having been purchased by the newly organized Methodist Church, South, at that place. The present building on Newnan street was erected by the Carrollton Church immediately following the removal of the old building. Rev. Walter B. Dillard was the pastor at that time and the following composed the building committee: C. H. Stewart, Chmn.; W. O. Perry, Treas.; C. M. Tanner, J. S. Travis, J. T. Bradley.

In 1875, the Carrollton church became a station. Rev. J. W. Stipe was the pastor that year. Then came Dr. W. F. Quillian for two years; David D. Cox, 1878; Dr. J. W. Lee, 1879-1880; Rev. D. L. Anderson 1881; Rev. J. Sidney Bryan, 1882; Rev. W. J. Scott, 1883 and a part of 1884; Dr. J. W. Heidt the remainder of 1884; Rev. A. W. Quillian 1885-1886-1887; Rev. Alexander Thigpen, 1888 and a portion of 1889. (Brother Thigpen died during 1889); Rev. Peter A. Heard balance of 1889; Rev. W. R. Foote, 1890-1891; Rev. John R. Parker, 1892; Rev. A. G. Worley, 1893; Rev. Clement C. Cary, 1894; Rev. G. W. Duval, 1895-1896; Rev. W. L. Pierce, 1897-1898; Rev. J. R. McClesky, 1899-1900; Rev. N. J. Ellis, 1901; Rev. J. R. Lewis, 1902; Rev. W. B. Dillard, 1903-1904-1905-1906; Rev. W. W. Dunbar, 1907-1908; Rev. A. W. Quillian (second pastorate), 1908-1910; Rev. R. A. Edmondson, 1911, 1912, 1913, 1914; Dr. A. M. Pierce, 1915-1916; Rev. W. T. Hamby, 1917-1918; Rev. W. H. Cooper, 1919-1920; Rev. J. P. Erwin, 1921-1922-1923; Rev. J. G. Logan, 1924; Rev. Frank Quillian, 1925-1926; Rev. Irby Henderson, 1927.

The magnificent parsonage at 97 Newnan Street, perhaps the largest parsonage in the North Georgia Conference, was built during 1912, while brother R. A. Edmondson was pastor.

The present membership of Carrollton M. E. Church, South, is 852. Col. R. D. Jackson is chairman, J. L. Thomasson, secretary, and S. B. Pace, treasurer of the Board of Stewards which consists of W. O. Perry, R. S. Brown, M. L. Fisher, John Stewart, W. O. Baskin, W. E. Johnson, H. J. Worthy, C. M. Tanner, C. A. Lyle, A. J. Baskin, Dr. O. W. Roberts, Lester Murrah, T. J. H. Robertson, T. W. Moore, J. B. Bledsoe, W. S. Campbell. Additional to these officers, Prof. I. S. Ingram is Superintendent of the Sunday School with W. O. Baskin as Assistant Supt., and W. C. Cantrell, Secy.-Treas. Mrs. L. K. Smith is President and Mrs. Edgar Johnson, Vice-President, Mrs. Sallie Cobb, Treasurer and Mrs. W. M. Meadows, Secretary of the Woman's Missionary Society, which has been an outstanding feature of this church since 1881, when it was organized with 24 members. This Missionary Society has furnished a District Secretary, Mrs. L. K. Smith, and Mrs. B. F. Boykin was Social Service Secretary for the North Georgia Conference for a number of years. Mrs. W. C. Cantrell is Superintendent of the Young People's Missionary Society, and Mrs. S. J. Boykin is Superintendent of the Epworth-Juniors. Miss Loise

Phipps is President of the Epworth League. Col. J. W. Stone is Lay Leader, and W. O. Perry, Chairman; R. S. Brown, Secy.-Treas.; W. W. Baskin, Dr. M. M. Hallum, C. M. Tanner, W. S. Campbell, W. J. Stewart, C. M. Stewart, J. W. Baskin make up the Board of Trustees. D. L. Hearn is Choir Director, and Hollis H. Gray, Jr., is Organist.

CARROLLTON DISTRICT

From 1894 to 1900, both inclusive, there was a Carrollton Presiding Elder's District. During 1894-1895-1896 Rev. A. W. Williams was Presiding Elder. In 1897 and 1898 Rev. M. J. Cofer was Presiding Elder. For the years 1899 and 1900, Rev. T. J. Christian was Presiding Elder.

VILLA RICA

Investigation of records in the office of the Clerk of Superior Court and of church records leads us to believe that the Methodist church at "Old Villa Rica" was organized about the same time as the one in Carrollton, about 1840-1845. This church is of very peculiar interest to Methodism in general and to the Methodist Episcopal Church, South, in particular, because it was the "Home Church" of the great apostle and defender of "the Faith Once Delivered Unto the Saints," Bishop Warren Akin Candler, the Senior Active Bishop of this Church. When the good bishop was a lad of eleven years his father was converted and joined the Methodist church and his mother, who had been a member of the Missionary Baptist Church, transferred her membership to the church of her husband. Soon thereafter their son, Warren Akin, applied for church membership and is baptized and received into the church by Rev. R. R. Johnson, the one-armed itinerant. This was during the year 1869, according to the records in hand for this historical To have given this one man to the Church and to the world sketch. would have been a priceless contribution, but this godly father and mother and this humble country church gave several others who have rendered valuable and distinguished service in Church and State. The Hon. Asa G. Candler, Sr., whose splended gifts, aggregating several millions of dollars, have made possible Wesley Memorial and Emory University; Judge John S. Candler, recognized as one of the ablest jurists of our Commonwealth and who has also made handsome donations to our educational institutions, and given unsparingly of his time and talents to the promotion of the work of the Church; Hon. William B. Candler, an outstanding and valuable citizen, of Villa Rica, and capable and honored leader in the Presbyterian Church, and a large number of the younger generation of this illustrious family are all the products, directly or indirectly of this and neighboring churches that were established by the early settlers of Carroll County.

In 1885, the forty-four members of "Old Villa Rica" transferred their membership to the Methodist Episcopal Church, South, at "New Villa Rica," and thus the present Villa Rica church had its beginning. It has had a healthful growth since that time and now has a membership of approximately 300. Rev. T. K. Maxwell is serving his first years as pastor, giving two Sundays a month to Villa Rica and two Sundays to Buchanan, Haralson County. Wesley Chapel and Powell's Chapel, both located in Carroll County, are on this pastoral charge, being served as afternoon appointments.

The following pastors have served Villa Rica since 1884: Charles S. Owens, 1885; E. H. Wood, 1886-1887; Sanford Leake, 1888-1889; Samuel R. Belk, 1890; M. S. Williams, 1891-1892-1893; William W. Dunbar, 1894; Fletcher Walton, 1895-1896-1897-1898; C. M. Verdel, 1899; D. M. Edwards,

Chambers now pastor on Bowdon circuit came from Villa Rica Church.

TEMPLE

About 1846, a Methodist church was built on lot of land No. 139, in the Sixth District of Carroll County. This church seems to have been dissolved by internal strife about the year 1854. The property was sold to the New Bethel Baptist Church. In 1857, Felix R. Walker deeded to O. A. Henson, Warren Chance, John Ballard and William Binder, Trustees of the Methodist church, one acre of land where the depot in Temple now stands. No church building was ever erected on this lot. In 1857 or 1858, a church was built on Lot 205, and in 1859 O. A. Henson deeded one acre of said lot to Wilson Cartright, Warren Chance, Jesse Cantrell, John Ballard, Andrew J. McAllister, Trustees of the Methodist church. A meeting-house stood upon the ground at that time. This church was known as Asbury and was located across the road from the graveyard. In 1882, the Annual Conference appointed Rev. S. H. Braswell, a local preacher, to the Temple Circuit and he was re-appointed for 1884, and also for 1885. During 1884, the church in Temple was organized by transferring membership of Asbury to Temple and a meeting-house was built the same year. In 1903, the present beautiful brick church was built by the Temple congregation, it being the first brick church to be erected in Carroll County.

From 1885 to 1920, the same pastors who served Villa Rica (See list) also served Temple. From 1920, now Temple and Concord have constituted a pastoral charge and have had the following pastors: 1920, B. F. Mize; 1921, W. P. Carmichael; 1922, B. S. Fleming; 1923-1924, A. F. Nunn; 1925, Z. V. Hawkes; 1926-1927, W. E. Brown.

BOWDON

There are three branches of Methodism in Bowdon, the Methodist Protestant, the Methodist Episcopal and the Methodist Episcopal, South. The first named seems to have been the first established, the date on organization being 1856. Dr. Chas. A. McDaniel was the first pastor of the Methodist Protestant Church in Bowdon, and also the organizer and first president of Bowdon College. He and the young men students of the college organized a company in the Confederate Army, the 41st Georgia, of which he later became Colonel. Col. McDaniel was slain in the battle of Perryville, Ky. The M. P. Church House in Bowdon is said to have been the place in which all the other churches in Bowdon, of the white race, were organized. In addition to the Bowdon church, there are six other M. P. churches in Carroll County, namely: Smith's Chapel, organized before the Civil War; Victory, Union, where a large camp-ground is maintained; Bowdon Junction, New Hope, and Carrollton. Rev. Andrew Jenkins is pastor of the M. P. church in Carroll County.

M. E. CHURCH, SOUTH

The Methodist Episcopal Church, South, appears to have been organized in Bowdon soon after the Civil War. The oldest members now living think that William C. Dunlap was the first pastor and Carroll County Methodism, Cont'd.

authentic Conference records place him in Carroll County during 1866-1867. In 1873-1874 Brother Dunlap is again in Carroll County and it may have been during these years that the church was organized. The deeds on record in the courthouse are dated 1873. The congregation is now using the third meeting-house, a beautiful and commodious brick structure erected during the pastorate of Rev. V. E. Lanford, 1909-1910. Since 1874, the following pastors have served Bowdon church: G. C. Andreks, W. M. Speer, junior preacher; A. J. Hughes, F. D. Cantrell, junior preacher; M. W. Arnold, Willie Arnold, junior preacher (These are father and son); Jere Reese; W. W. Braswell; J. N. Myers, W. T. Irvine, junior preacher; N. W. Morris, Seals Askew, junior preacher; H. L. Sdmondson, 1889-1891; W. E. Tarpley, 1892; J. S. L. Sappington, 1893-1894; C. C. O'Neal, 1895; missing, 1896; B. P. Searcy, 1897-1898; H. W. Morris, 1899-1900; J. A. Thurman, 1901; Walter Millican, 1902; J. R. Speer, 1904-1905-1906; J. M. Fowler, 1907-1908; V. E. Lanford, 1909-1910; W. A. Maxwell, 1911-1912-1913-1914; J. A. Sewell, 1915-1916 (Bro. Sewell went from Bowdon to be Chaplain of the Federal Penitentiary, Atlanta); T. M. Elliott, 1917 (Bowdon changes from LaGrange to Rome Dist.); M. K. Patillo, 1918; W. A. Maxwell, 1919-1920-1921-1922 (second pastorate); C. V. Weathers, 1923-1924; A. F. Nunn, 1925; R. F. Elrod, 1926-1927); Rev. C. M. Lipham, now pastor at First Church, Newnan, was formerly a member of Bowdon Church.

Shiloh Church, Burwell, organized about 1844, is grouped with Bowdon in a pastoral charge, each being a half-station. A campground is maintained at Shiloh. Rev. J. A. Griffies, now pastor at Carnesville, came from Shiloh.

In 1918, the Bowdon circuit was formed, composed of Garrett's Chapel, Midway, Tyus and Veal, and has been served by the following pastors: G. A. Chambers, 1918; Clifton Freeman, 1919-1920-1921-1922; supplied 1923; H. C. Stratton, 1924-1925; W. J. Cantrell, 1926; G. A. Chambers, 1927.

We were unable to get the date of organization of the Methodist Episcopal Church in Bowdon; but it, too, probably dates back to the years immediately following the Civil War. American Episcopal Methodism divided in 1844, and soon thereafter old New Salem Church in this county divided, a portion forming Mt. Zion M. E. Church and others forming Shiloh M. E. Church, South. At Mt. Zion the M. E. Church has a good school known as Mt. Zion Seminary (We leave further reference to this school to the writer of the Educational History of Carroll County), and this place is headquarters for this denomination in this section. Bethel Church was organized soon after Mt. Zion and Bowdon probably came next. Ramah is another M. E. Church in this county. These four churches are grouped in a pastoral charge of which Rev. N. S. Hamilton is pastor. Dr. H. H. Bowen, District Superintendent, also resides at Mt. Zion. At Bethel there is a large camp-ground, where camp-meetings are held annually.

WHITESBURG

The Whitesburg church was organized in 1874. W. C. Dunlap was the first pastor. Then came W. A. Simmons, 1875; David Nolan, 1876; W. A. Parks, 1877; J. L. Perryman, 1878; John W. Quillian, 1879-1880; Jas. D. Hollinshead and F. D. Cantrell, 1881; W. H. Speer, 1882-1883; T. G. Morgan, 1884; G. C. Andrews, 1885-1886-1887; W. J. Wood, 1888; W. H. Speer, 1889-1890; Artemus Lester, 1891-1892-1893; J. N. Snow, 1894; W. G. Crawley, 1895; O. L. Kelley, 1896; R. C. Cleckler, 1897;

At one time the Methodist Church owned and operated a Secondary College, Hutchison Collegiate Institute, at Whitesburg.

Grouped with Whitesburg in a pastoral charge are the following churches: Hulett, St. Paul, and New Hope. Rev. P. Eugene Buyers, a missionary to Brazil, was brought up in St. Paul's Church and his father and mother are still dependable members of this church.

ROOPVILLE

Roopville Methodist Church was organized in 1883, by transfer of membership from Mt. Zion Church (near Roopville). That church was in existence as early as 1874, being on the Bowdon Circuit (See list of pastors for Bowdon). The Roopville circuit appears to have been constituted in 1891, J. W. Bailey being the preacher for that year. Then followed J. P. Burgess, 1892; William Murdock, 1893; missing, 1894; N. E. McBrayer, 1895-1896; H. W. Morris, 1897-1898; E. W. Jones, 1899-1900-1901-1902; missing 1903-1904; W. R. Kennedy, 1905-1906; W. W. Benson, 1907-1908-1909-1910; B. H. Green, 1911-1912; R. P. Tatum, 1913-1914-1915; W. A. Wells, 1916-1917; Lucien Roper, 1918; W. A. Woodruf, 1919-1920-1921 (In Rome District); W. P. Carmichael, 1922; O. J. Withrow, 1923; Z. V. Hawkes, 1924; B. W. Kilpatrick, 1925-1926-1927.

Lowell church, organized in rather recent times, in Carroll County, and Caney Head, in Heard County, are associated with Roopville in a pastoral Charge.

Rev. E. G. Thomasson, now pastor at Washington, Ga., was reared at Roopville and formerly belonged to Roopville Church, to which church some of his family still belong.

CARROLL CIRCUIT

Stripling Chapel was organized just before the Civil War and was named after David Stripling, who had rendered pastoral service in Carroll County for many years prior to and during the war. Brother Stripling's grave is in the Smyrna church-yard, another of the churches now composing the Carroll circuit, where he had labored much and most acceptably. A few years ago some of his admirers, including Hon. J. J. Thomasson and Judge J. T. Norman, led in a movement to erect a monument to the memory of this noble servant of God. A beautiful monument now marks his grave.

Old Camp is thus named because it was formerly the location of the camp-ground which is now at Shiloh. This church was probably organized about the same time as Stripling Chapel. Rev. W. P. Turner, who was for twenty years one of our missionaries to Japan, was brought up in this church, and his kinfolks are still among the most substantial members. Clifton Freeman, now pastor on the Rome circuit, and Paul Turner, now pastor at Lindale, also came out from this church. Center Point is the youngest of the churches on the Carroll

circuit, but is a thriving institution.

There is scarcely a church in Carroll County which has not some

Brother R. P. Tatum, superannuate, has charge of the church at Clem, which is also a part of the Carrollton Circuit at this time. Clem Church was organized in 1899, by Rev. W. L. Davenport, a local preacher of unusual ability who served many years as a supply in Carroll County. Old Temperance Church, at Old Carrollton, where is said to have been born the first Temperance organization in Georgia (Hence the name) was once a part of the Carrollton circuit but was abandoned some years ago. During 1895 or 1896 there was a Temperance circuit, served by A. G. Shankle.

CONGREGATIONAL METHODIST CHURCHES

There are six Congregational Methodist Churches in Carroll County at this time, namely: Lee's Chapel, Fairview, Liberty, Shiloh, Rotherwood, Cross Plains. In doctrine they agree with all other branches of Methodism, but are distinguished by their method of providing preachers for the churches, each congregation calling its own pastor.

There is also one Free Methodist Church, located at Hickory Level.

COLORED CHURCHES

There are nine Methodist Churches in Carroll County among the colored people. Moore's Chapel (Carrollton). Roopville and Bowdon of the M. E. Church form a pastoral charge of which Rev. M. W. Burch is pastor. Temple, Villa Rica and Poplar Springs, of the M. E. Church, form a pastoral charge of which Rev. J. C. Cunningham is pastor. Carrollton, Kite's Chapel, and Mt. Olive, of the African Methodist Episcopal Church, constitute a pastoral charge, but we are unable to ascertain the preacher's name.

In the limited time available and utilizing all records that we could lay hold of, we have done the best we could and hope that these archives will be of value to future generations.

PROLOG

The Jacksons came to America with the early settlers in Jamestown, Virginia. When the Muster was taken in 1624/25 there were nine or more male Jacksons listed, some had their wives and children and were well established in their homes by that date. It is not known how our particular line of Jacksons descended from these first settlers. Fires and wars have destroyed many vital records making it most difficult to trace the lineage back to the first immigrant.

Family tradition states that our line of Jacksons is of Scotch extraction but until the line is traced back to the immigrant no definite conclusion can be made. It cannot be denied that many Scotch traits are found prevalent even in the current generation.

Our first documented Jackson ancestor was Ambrose Jackson, who, with Ralph, Thomas and John Jackson were settled along the Meherrin River and Reedy Creek section of Surry County, Virginia in 1719. They had obtained adjoining grants of land about the same time and it is conjectured that they were brothers. This part of Surry was cut off to become part of Brunswick County when it was created in 1720. The given names, Ralph and Thomas were found in Henrico and Prince George Counties during the preceding decade. It is possible that our Jackson ancestors came from one of these older counties but the destruction of records has prevented confirmation. These given names were not common among the Jacksons in Surry County. The name, Ambrose Jackson, was found in the York County records.

This little community of Jacksons lived and prospered in this location for four generations during that period of our history preceding the Revolution, the signing of the Declaration of Independence, and the founding of a new republic, the United States of America.

After the conclusion of the Revolutionary War a great restlessness came over the people. They had tilled the same fields for decades and their lands had become impoverished. People began to think of the vast new lands available in the West and South; the era of great mass migrations had begun. Our ancestors in Virginia were attracted to the state of Georgia where virgin land was plentiful, the climate was mild and a welcome awaited them. So, the latter part of the 18th century found them disposing of their property in Virginia and joining their neighbors on the long and arduous treck southward through the Carolinas to Georgia where many of their descendants are found today. Others continued westward as new territories were opened for settlement, leaving a string of cousins from Alabama to Texas.

MARK JACKSON

Mark Jackson was the son of Henry Jackson (the son of Ambrose and Anne Jackson) and his wife, Mary, of Brunswick County, Virginia. His birth date is not known, however, since the first records of him are found in 1758, the year he served in the Brunswick County Militia with his brother, Henry, and also the year his father, Henry Jackson, presented him with a deed for 240 acres of land in Brunswick County for "love and affection," It may be assumed that he became of age that year and probably was born in 1737, or before.

Mark Jackson married Martha Warren, daughter of Benjamin Warren of Brunswick Co., Va., a member of one of the old and respected families

of James City and Surry Counties, Virginia. The marriage records of Brunswick give the marriage date 17 May 1778. This date is an error caused by a misinterpretation of the will of Benjamin Warren from which it was taken. Benjamin Warren's will was dated 17 May 1778 and stated "....I give to my grand children that is the issue of my daughter, Martha Jackson by Mark Jackson, her husband, the following Slaves...." Actually it is known that one child, John, was born in 1771 so obviously the recorded date of marriage is wrong.

No record has been found that Mark Jackson served in the Revolution but there is no doubt of his loyalty to the cause. He was mentioned at least three times in the Court Records of Brunswick Co. as having furnished supplies to the army. His name is recorded among the patriots in the National Society of the Sons of the American Revolution.

Mark Jackson and his wife, Martha, had nine known children, all sons, and there are family records in possession of some of their descendants that there were eleven sons and one daughter. The known children are as follows: (1) John, married Mary Harwell; (2) Jethro, married Amy Sledge; (3) Henry; (4) Wilkins, married Sarah Lamar; (5) Warren, married Elizabeth Rosser; (6) Mark, married Hollinsberry Sturdivant; (7) Edmund, married Clara Harris; (8) William, married Nancy Sledge; (9) Robert.

A study of the following records reveals that Mark Jackson owned several plantations in Brunswick Co. in St. Andrews Parish, and on both sides of the Meherrin River. His ancestors had lived in the same vicinity for three generations since the formation of the county in 1720. Life had been good to them and they had prospered. They lived the life of the Colonial Planter with large estates and many This was fine as long as there was an abundance of new land slaves. to be cleared and planted but after the Revolutionary War so many new people had settled in the area that land was at a premium. This meant that the same old fields had to be replanted year after year until the natural fertility of the soil was depleted. Fertilizers and crop rotation were not practiced then. News was circulated of the vast free lands to the west and south. The period of mass migrations was beginning.

Mark and Martha Jackson began looking about for more space in which their nine sons could settle and establish homes of their own. Many families migrated westward but to those in Southside Virginia such as Brunswick County the mild climate and liberal land policies of the State of Georgia were more appealing. It was not long until they found themselves joining the caravans with their neighbors and taking the trail that led through North Carolina to Georgia, the "Land of Promise." It is to be noted that Mark did not sell his home and plantations in Virginia before making this trip to Georgia. This was to be an exploratory trip to see what lay ahead of him before he cut all ties with his old home. No doubt he liked what he found as can be seen from the records which follow.

The Georgia Land Grant Records show that one Mark Jackson was issued a warrant for 350 acres in Burke, now Jefferson County, in 1787. This land adjoined land also owned by Mark Jackson. Since the Burke County records have been destroyed it cannot be determined whether this Mark is identical with the one covered by this manuscript or not. The grant lay along Lambert Creek and this compiler feels that it may have belonged to a Mark Lambert Jackson who finally settled

and died in Maury Co. Tenn. This Mark was probably related in some way to the one covered in this manuscript.

The 1795 Tax Returns for Hancock County, Ga. lists Jethro, Henry, John and Martha Jackson all in Capt. Barron's District. Martha paid taxes on 100 acres land on Sandy Run Creek in south-westerly part of the county near the Oconee River and also on 34 negro slaves. Why Martha paid the taxes is not known because married women were not permitted to own land in Georgia. It is possible that Mark had returned to Virginia leaving his wife and the boys behind.

By May, 1796, Mark and Martha Jackson were back in their old home in Brunswick County, Va., disposing of their property, both real and personal. They sold 33 negro slaves, livestock, furniture and household goods to Ben Jackson. Next month they sold their plantation on the north side of the Meherrin River. The following year, 1797, a deed for the balance of their land in Brunswick Co. was made as a gift to their son, John. Thus, Mark Jackson having disposed of everything he owned in Brunswick County, made his will on 1 Dec. 1797, which was probated on Christmas day of the same year.

Apparently Mark Jackson returned to Virginia with the intention of disposing of his remaining property there and returning to Hancock County, Ga., to make his permanent home. He had left 34 negro slaves in Georgia and sold 33 in Virginia. This may indicate that he intended operating on a smaller scale in Georgia. Evidently his plans had to be changed suddenly when he realized that he had acquired a fatal disease and made his will. His death came only three weeks later. Since his son, John, only four days after his father's death, sold the plantation given to him by his father, it would appear that the family had prearranged plans to leave Virginia forever.

The lawsuit instigated by Mark's son, Henry, against the estate to force the sale of 100 acres of land left Mark's wife, Martha, by her deceased brother, Benjamin Warren Jr., is interesting. This was possibly a friendly suit within the family to clear the title and disposition of this property. Mark, in making the deed to John for the 428 acres, stated that it covered all the property owned by him in Brunswick County. Mark's will mentioned only property held by him in Hancock County, Ga., hence the status of this 100 acres was in doubt. All of this may have come about through oversight due to Mark Jackson's haste to get his affairs in order before his death.

Mark Jackson, in his will, made no legacy to his older sons, Jethro, John, Henry and Wilkins. He had probably given land to each son as he became of age, as was the custom at that time. No record, other than the 1795 Tax return, has been found to show when or how the Hancock Co. property was acquired or the disposition of same. This may be attributed to the fact that this portion of Hancock County was created in 1793 from Washington Co. whose records were destroyed by fire in 1855 and by Sherman in 1865.

This closes the era of Mark Jackson. This man had proven himself a patriotic citizen, a successful planter, and a devoted husband and father. He had been reared during the Colonial period of Virginia, brought his family safely through the trying days of the Revolution, and left his nine sons a heritage of family and fortune of which to be proud.

A negro by the name of Pink Dobbs, who moved from near here to Atlanta a year or two ago, met his death recently near Atlanta by being suffocated by gas in a well, in which he had descended.

Gold Mining in Carroll - From W. O. Tuggle we learn some interesting facts in regard to the gold mining operations in Carroll County. Mr. Z. Bonner began mining for gold eight miles southwest of Carrollton in 1840, and since that time carrying on his own operations desultorily has realized the gross sum of two hundred thousand dollars. Mr. Bonner's tract of land contains about 1215 acres and as he is growing old it is probable that he would sell at least a portion thereof to some capitalist desiring of engaging in mining. He has recently leased certain veins for five years to Prof. A. Thies and Prof. Warncekee, and these gentlemen are erecting two ten stamp mills capable of crushing sixtyfive to seventy tons of ore a day. As an evidence of the richness of the ore, it may be stated that Mr. G. A. Bonner is realizing \$25.00 a day with a simple "rocker." It may be that this portion of Old Carroll will come to be known as Bonner's Bonanza. -- From the Atlanta Constitution.

Bonner. This book is a well-documented history of the County, originally published by the University of Georgia Press in 1971. It has been unavailable for several years.

Dr. Bonner was a native of Carroll County, and was a member of the faculty of West Georgia College in Carrollton.
